Council considered a report at the August Ordinary Meeting, where it noted the need to undertake a policy neutral translation to the Activity Centre Zone as a first step to potentially applying the ACZ to the Bridge Street Business Area as part of future amendment C107. Notification of the amendment was given to the prescribed Ministers in accordance with the provision of the <i>Planning and Environment Act 1987</i> . Latest action: <ul style="list-style-type: none"> Council adopted the amendment at the October Ordinary Meeting, and forwarded it to the Minister for Planning for approval. Next action: The Minister for Planning will consider whether to approve and finalise the amendment.
