4. Business arising

 RTAC position – adverstised and no suitable applicants so position will remain vacant until we readvertise later this year.

ACTION: Officers to advertise in the local magazine, newspaper, social media and through service providers

 DCT to Main Yarra Trail change in surface – Faye Williams, Regional Officer, is currently on leave. Officers will be meeting with Faye in July so will raise this at the meeting. Committee should lobby Environment Minster

5. Regional Trails update

a) Northern Regional Trails Strategy

- In advocacy phase to secure as much funding for the region
- Funding was received for DCT as part of this advocacy work.

b) Diamond Creek Trail

- The cost of the Trail project is estimated at \$11 million, consisting of \$4 million for land acquisition and compensation and \$7 million for trail construction.
- The State Government has announced the 2018-19 Victorian Budget includes an investment of \$4 million towards the construction of the extension of the Diamond Creek Trail.
- Officers are continuing to explore further grant opportunities with both State and Federal Government to assist in meeting the project budget shortfall of \$3 million. Officers are expected to submit a funding application when the Building Better Regions Fund becomes available.
- Advocating for additional funding has been with the collaborative support of Trailblazers Inc. The committee has had many meetings and corresponded with both parties, State and Federal members and State Government Ministers.
- With the assistance of Trailblazers Inc. an advocacy strategy and communications plan has been prepared for the purposes of obtaining further broader community support for the Trail's extension.

Project timelines

- June December 2018: undertake the acquisition and associated compensation process to acquire privately owned land.
- February May 2019: subject to securing the necessary funding, commence preliminary works, fence of trail corridor and complete detailed design.
- March May 2019: complete remaining technical studies and reports.
- May August 2019: tender process for bridges and boardwalks and construction of trail.
- September 2019 Late 2020: Constructions

c) Aqueduct Trail

- Officers met with Cath Giles to understand history of the southern vs northern alignment of the trail
- Northern alignment, as per the Recreation Trails Strategy, along Ridge Road is being discussed with Melbourne Water through the masterplanning process for Christmas Hills.

ACTION: Officers to send possible dates in July for group to complete site visit of the current proposed trail alignment

 Melbourne Water has now sent through their ownership and access map which will be overlayed with Council's ownership map in the coming weeks.

ACTION: Officers to seek iconfirmation of boundaries from the Titles office

 There is an indicative \$8,000 in the 2018/19 budget to assist in the planning for the Aqueduct Trail (around Sugarloaf), officers will continue to work with Melbourne Water and Yarra Ranges to develop a preferred alignments and experiences. This is important to connect to the Warburton Trail

d) Green Wedge Trail

 At this stage there is no further planning work being completed for this Trail.

6. Local Links - Cherry Tree Road

 Council owns a parcel of land adjacent to 290 Cherry Tree Road but property team are currently confirming whether there is a formal lease with the adjacent property owner.

ACTION: Officers to follow up with property team to confirm prior to next meeting

- Planning permit has been approved and contractors are back on site.
- Unsealed trail will be finished by end of June with properly crossings being completed throughout July.
- TAC funding acquittal will be completed in July along with final audit.

7. Panton Hill Bushland Reserve User update

- Works Update weed control, rabbit control, threatened orchid reintroduction program
- Trail assessment report feedback Although this report was discussed soon after its completion there was renewed interest in it recently from an external community member. The following points were discussed:
 - Report provides a benchmark to monitor the resilience of bushland trails over time to see if there are any particular trends in their deterioration.

- It is very difficult, scientifically, to distinguish the impacts of specific trail use as opposed to general erosion by water.
- The report indicates sections/ characteristics of trail that are more likely to erode, mainly due to slope and water movement, which can inform a maintenance program.
- Maintenance is reactionary at this time however council needs to allocate budget to maintain potential trial erosion hot spots, thereby making trials sustainable into the longer term for all users.
- Biodiversity On Ground Action grant project update on threatened species monitoring program with volunteers, discussion about chainsaw hollows for habitat
- Interpretation Concept Plan implementation –need to get buy in and embed the interpretation concept project into the right places in the organisation, need to resource project manager, budget carried forward

ACTION: Officers to follow up on the difference in approach between PHBRS and RTAC as there should be consistency between both

8. Working groups - report back

- Over March and April 2018 two RTAC working groups met to progress development of our trail inventory and classifications of our trails
- <u>Trail management</u> undertook and discussed justification for trail classification.

Review of Trails Strategy existing classification system as Regional, Local & Cultural; Review of Trails Strategy existing Recreation Trail Experience Based Matrix: Bushland Trail, Bridle Trail, Rural Road Trail, Roadside Trail, On-road Cycling Trail and Off-road Trail and Use of existing standards to help classify our trails, such as: Australian Walking Track grading Standards, Mountain biking system (IMBA Australia Trail Difficulty Rating System) and Horse trail classification.

ACTION: Classifications to be bought up to the next RTAC meeting for consderation by the entire group prior to a Council resolution

 <u>Trail mapping</u> – undertook a review of existing trail network. Group understand the constraints and issues within Council current mapping system and available data. Land ownership issues were discussed and officers will address once mapping and ownership is known.

A mapping resource will be developed in the short term.

ACTION: Trail inventory list to be bought up at the next RTAC meeting for consderation by the entire group

ACTION: Officers to review trail inventory list on GIS to identify which trails (or portion of trails) are in Council ownership and which are not. Agreements will need to be entered into by Melbourne water, VicRoads, Parks Vic etc.

9. Local links priority 2018-19

 the planning application to clear vegetation along the high side of the road,
 creating space for horses, pedestrians, etc. This is still currently being
 assessed
