Can I thank the staff of Council. The CEOs' Stuart Burdack, Mark Stoermer and now our newest asset Carl Cowie. The senior Executive Management Team.

All staff have been delightful and supportive of the many initiatives and issue we raised. Of all the unique matters that have arisen their cheerful attempts to resolve the matters in a timely supportive manner has made the job much easier.

Can I also thank the Council and the Municipal Association of Victoria and its President Mary Lalios for recognising me with awards of Mayor Emeritus and the 15 year service award a couple of weeks ago.

The response from the community and local government sector together with local Members of Parliament has been much appreciated.

I have the tolerance and support of my family Susan, Kathryn and Loren and in the last 12 months our new son in law Tim.

My family have endured over 16 years in local government thus far.

Discussing the Council agenda and what should occur either at Heidelberg Melbourne or Nillumbik is not usual in most families.

They have always had helpful and considered suggestions. I am grateful for the continued support and love.

Met some fantastic residents doing amazing things, supportive, concerned, engaged active, committed I have attended Citizenship. Celebrated Citizens of the year. Our green wedge review as well as Activity centre zones review, Arts funding increased, Commencement of a feasibility for Art Gallery, Arts Policy developed, More money for festivals, Shakespere in the Park, Community Wellbeing, Inclusive and caring for all ages recognising we are fast becoming ageing population, Environment/Energy, Solar farm, Waste management improvements, Bushfire mitigation, Excellence in our parks and gardens and Footpaths and Economy.

- Economic Development and Marketing

- Finance and Governance
- Infrastructure
- Social Infrastructure
- Planning

In accordance with the Future Nillumbik Committee Terms of Reference, the membership and chairperson arrangements for the Committee are as follows:

- All Councillors are members of the Future Nillumbik Committee.
- Council assigns individual portfolio responsibilities to individual Councillors and the agenda shall identity which items of business relate to the respective portfolios.
- The Chairperson for each particular item shall be the Councillor with the relevant portfolio responsibility.
- When a Councillor is in the role of Chairperson, they will have the power and authority of the Chairperson as provided in the Meeting Procedure Local Law, including a casting vote.
- At the commencement of the meeting, when preliminary matters are considered (such as apologies, confirmation of minutes, and declarations of interest) the Mayor shall be the Chairperson.

14. Address by the incoming Mayor

I thank you Seanna for understanding that I can't always do the school run.

I thank you for your understanding that I'm not always available to drop over as frequently as I used to

I thank you for always being there when ever I pick up the phone,

I thank you all for putting up with my sms messages,

and Michelle you know you're on the top of that list.

Thank you to my fellow councillors. I thank you for your guidance and support, for the freedom to have a differing opinions and I thank you for your confidence in electing me as mayor to continue to deliver on the ambitious council plan we set out when we were elected two years ago.

In particular can I thank Cr Peter Clarke as outgoing Mayor. Cr Clarke has been relentless in his pursuit for the best outcomes for our Shire.

Relentless in ensuring council has more than it's fair share in state and federal funding. Relentless in adopting a low rating strategy, ensuring Nillumbik the pressure on ratepayers who have historically had the highest rates in the state, get some relief moving forward. A zero rate increase, the only council in Victoria to achieve such a courageous move in 2017.

Relentless in paying down council debt and ensuring responsible financial Management.

And relentless in our pursuit to become Australia's most liveable Shire.

Cr Clarke on behalf of the Shire we say thank you.

I also want to take a moment to thank the residents of Bunjil and give you my commitment that rural residents will not be forgotten. We live in a unique Situation in our Shire.

I make no apologies up front for putting rural residents front and centre over the next year.

Before I go into the upcoming year I also want to thank the hard working officers of Nillumbik Shire Council. We know that this council has achieved a lot over the last two years. It has been an ambitious agenda and your contribution to our success does not go unnoticed. Thank you and I look forward to continuing to work with you into the future.

I look forward to a year of continued action, continued advocacy for more state and federal funding, continued delivery on the multitude of sporting pavilions and upgrades to improves female participation in sport.

Continuing on some of the smaller projects that might not make the news, but make a big difference in our local communities. The footpath upgrades to ensure our kids have a safe path to school. Upgrades to intersections, upgrading drainage, sealing roads and helping address the need for community spaces for the hero's of our community. The likes of The Mens Sheds, and other such community groups.

Right now is a great time to live in our Shire. This council has committed to the economic development of our Shire. We want to attract visitors, the very visitors who will spend money at our cafes, our accommodation, our wineries and our farms. We want visitors to support our artists. We're proud of our artistic heritage and want to build and foster our arts and cultural industries.
